

**TERMS AND CONDITIONS  
SINGLIFE CAR, TRAVEL AND HOME INSURANCE PROMOTION  
FOR MINDEF AND MHA INSURED MEMBERS  
(the “Promotion”)**

1. This Promotion is valid from 14 February 2025 to 31 December 2025 (both dates inclusive) (“**Promotion Period**”) and is organised by Singapore Life Ltd. (“**Singlife**”).
2. Only Qualifying Customers are eligible for the Promotion.
3. To be a “**Qualifying Customer**”:
  - a. You must purchase the Qualifying Plan(s) (as set out in Clause 4) during the Promotion Period (i.e. from 14 February 2025 to 31 December 2025);
  - b. You must:
    - (i) Have an active MINDEF / MHA Group Term Life or Group Personal Injury Plan (“**Qualifying Member**”); or
    - (ii) Be an immediate family member (as defined at Clause 5 below) of a Qualifying Member;
  - c. You must key in the particulars of the Qualifying Member (as set out in Clause 5 below) during the Qualifying Plan application.

5. As a Qualifying Customer, you must be able to provide the relevant details and/or documents required below.

Immediate family member refers to the spouse, parents, siblings and children of a Qualifying Member.

Discounts will not be given if the relevant details and/or required documentation is not provided.

Qualifying Member	<b>Date of Birth and last 4 characters of NRIC/Fin</b>
Spouse of Qualifying Member	<b>Documents to provide:</b> Copies of relevant marriage certificate must be submitted with the application as proof of relationship, and the details of the relevant Qualifying Member.
Parents/Siblings/Children of Qualifying Member	<b>Documents to provide:</b> Copies of birth certificates (of the Qualifying Customer and Qualifying Member) must be submitted with the application as proof of relationship, and the details of the relevant Qualifying Member.

  8. Singlife reserves the right to verify whether a Qualifying Customer is eligible, and claw back the premium discount if Singlife discovers that the Qualifying Customer is not eligible for the Promotion or failed to meet any requirement of the Promotion.
  9. Discount is given on a per policy basis, subject to underwriting.
  10. The discount is not exchangeable for cash, credit, or any other item in part or in whole.
  11. In the event of any cancellation of the Qualifying Plan where a refund is applicable, only the amount of premiums you have actually paid will be refunded, subject to the terms and conditions of the Qualifying Plan.
